

# Telephone Attachments

---

---

Telephone attachments are being peddled in a miscellaneous manner throughout the country and are purchased by unsuspecting or unthinking users and attached to their instruments. Generally the so-called "helps," disinfectants, etc., are a positive hindrance to telephone service, not being so designed as to secure the maximum of efficiency in hearing or speaking.

Many of them get the lines and instruments into trouble, whereupon the Company, to protect its service, is obliged to remove them. Rubber earpiece attachments do not augment the sounds received, and often make it impossible to hang the telephone properly upon the switch-hook. Essentially the same result can be obtained by closing one ear with the palm of the hand. The instruments should be kept clean by wiping them.

Telephone instruments, necessarily very sensitive and intricate, have been designed to produce the best results as they are. In the interest of good service, subscribers are recommended to make no attachments of any kind to their instruments.



It is dictated, typewritten on office stationery, with a carbon or letter book copy for the file, addressed, stamped, and transmitted by mail to its destination.



A MILWAUKEE AUTOMOBILE AGENT calls out-of-town customers on the telephone, to whom cars have recently been sold, and asks if friends have admired the cars or expressed any thought of buying. He follows up the prospects and has made several sales in that way.



A WORCESTER, MASS., FIRM sends circular letters to selected lists of out-of-town horse-owners, and follows these up with telephone talks, securing many orders for carriages, harness, etc., as the result of telephone salesmanship.



A WELL KNOWN BOSTON LAWYER recently settled an important civil case out of court by the long distance telephone. The plaintiff was in Trenton, N. J., while the defendant was in Northampton, Mass. By reaching both parties an agreement was reached and the cost of trial avoided. The telephone charges were less than ten dollars, while at least a thousand dollars was saved in the cost of a trial and other expenses.



THE YEARLY SALES of a wholesale lumber dealer of Boston aggregate about 3,500 cars, of which 1,500 cars were sold by long distance telephone, the telephone sales aggregating upward of \$1,000,000.



A LARGE MANUFACTURING COMPANY of Greenfield, Mass., has established six sales centers throughout the United States at which long distance telephone orders will be handled exclusively. These offices will be managed principally by long distance telephone from Greenfield.



AT BANGOR, ME., a wholesale hay and grain dealer formerly had two salesmen on the road. Now the firm keeps them for office work and city canvassing, and does all its out-of-town selling and collecting by telephone.



A SALESMAN for a large Chicago company covers the trade in Southern Wisconsin exclusively by telephone. He goes to Madison, from which point he calls about three hundred customers, and usually disposes of about two hundred carloads of coal at a profit of \$20.00 a car. Two days' telephoning campaign costs him all told about \$75.00.



BY MEANS OF A LONG DISTANCE TELEPHONE follow-up call, a Milwaukee jobber found a customer at Monroe, Wis., much displeased with previous shipments and disposed to withhold further orders. The matter was satisfactorily adjusted over the long distance telephone and another large order secured.
